# Report from the Ohio Attorney General's Office

Lori Anthony, Civil Rights Section Chief – Ohio Attorney General's Office shared news of the passing of Principal AAG Marilyn Tobocman. Ms. Anthony reflected on fond memories of Marilyn and shared stories of her hard work and dedication.

Chairman Hubert requested a moment of silence in memory of Marilyn and her service to the OCRC, the AG's office and the State of Ohio. A moment of silence was observed.

# **Report from the Chief Legal Counsel**

Chief Legal Counsel, Stephanie Demers took a moment to also acknowledge the work of Principal AAG Marilyn Tobocman, whom she previously supervised for 10 years. She shared three examples of Marilyn's tenacity and determination. She first shared Marilyn successfully litigated the first emotional support animal case in the Civil Rights Section. Second, she shared Marilyn's work on the Tippecanoe Country Club case. Finally, she shared Marilyn's success in the \$4 million settlement in the Farmers Insurance redlining case. Farmers had retained Robert Bennett, former attorney to Bill Clinton. Marilyn held her ground with Mr. Bennett and it was one of her proudest moments as an Assistant Attorney General. Marilyn will truly be missed.

### **Report from Executive Director**

Executive Director, G. Michael Payton reflected on the life of Marilyn Tobocman. Marilyn was an extraordinary lawyer and fair housing advocate who served the OCRC and AG's Office with great distinction. Early in life Marilyn was a stay at home mother who eventually decided to go back to school to become a lawyer. She graduated one year earlier than her daughter from Cleveland Marshall Law School. Marilyn was a very humble person with a pleasant personality; an outstanding legal advocate who was dedicated to helping the downtrodden and victims of discrimination. Among her many achievements, Marilyn will be remembered for her work as the lead counsel in the OCRC's successful case against Farmers Insurance Company where she secured millions of dollars in relief for insurance redlining against African-American families in Toledo, Ohio. We will miss Marilyn and we thank her for all that she has done for our agency and the cause of equality. May she rest in peace.

Director Payton also acknowledged the passing of Carol Coaston. Carol was a 47 year employee with the fair housing organization Housing Opportunities Made Equal (HOME) in Cincinnati, Ohio. She was an outstanding fair housing advocate and a kind soul who always treated others with respect.
